Introduction

Beas Cheerleading are committed to protecting the privacy of our athletes, parents and guardians. This Privacy Policy is designed to let you know what information we collect about you, how we store it and how we use it.

As of July 2018 Beas Cheerleading will be using Love Admin to manage athletes and coaches at the club, this includes weekly registers. Therefore, all current hard copy registration forms will be destroyed.

Love Admin allows athletes, parents and guardians to share as much and as little information with Beas Cheerleading via a membership account. This account is protected by each individuals own password. We keep this Privacy Policy under regular review and we reserve the right to update it without notice. We recommend you visit this section regularly on our website as continued membership will constitute acceptance of the new Terms.

Statutory Obligation

We are registered with the Information Commissioner's Office (ICO) and we appear on the Data Protection Public Register (Registration Ref: ZA362486). We are committed to compliance with all relevant data protection legislation, including the General Data Protection Regulation effective 25th May 2018 (which replaces the Data Protection Act 1998) and Privacy and Electronic Communications Regulations 2003.

What information do we collect about you?

We collect information about you when you register with us via Love Admin, contact us or place an order for our services. We also collect information when you voluntarily complete surveys, and or provide feedback.

Website usage information is collected using cookies. Further details on our use of cookies can be read below.

How will we use the information about you?

We collect information about you to send you details about future products and or competitions we may have to offer. When processing your order (such as your name, postal address and e-mail address) to manage your account. We will also use this information in the case of an emergency, should you (the athlete) / your child need medical attention. With your permission we may opt to contact you via telephone, SMS, social media, post or email. Please inform us of any methods you wish to NOT be contacted by.

We shall use your personal information for: a) contacting you in the case of an emergency; b) for delivering any detailed information about competitions; c) for any regulatory or legal purposes imposed on us; d) for informing you about other services and products provided by us (where you have provided your consent); and e) for any other legitimate interest of ours such as for preventing fraud, maintaining adequate records or for the recovery of unpaid debts.

You have the right at any time to stop us from contacting you for marketing purposes or giving your information to companies outside of Beas Cheerleading. If you no longer wish to be contacted for marketing purposes, please e-mail info@beascheer.co.uk
Some or all of the information you supply to us in connection with your membership- may be passed to third parties including: a) insurance; b) service providers (such as Competition Ep's); c) other sub- contractors who may assist us i.e choreographers.

Marketing

We would like to send you information about our product and services, as well as carefully selected companies in our group, which may be of interest to you and where you have consented to receive marketing.

Unless we hear from you otherwise, we shall keep you informed of any promotions, discounts or other products and services from Beas Cheerleading that we think may be of interest to you for up to 6 months from your last interaction with Beas Cheerleading.

Following such period, we shall assume that you are no longer interested in such promotions, discounts or other products and services.

Access to your information and correction

You have the right to request a copy of the information that we hold about you. We want to make sure that your personal information is accurate and up to date. You may ask us to correct or remove information you think is inaccurate, alternatively this can be done yourself via your Love Admin account.

How long we will keep the information for

Your information will be kept for no longer than is necessary for the purposes for which the personal information is processed. In doing so we may retain such information for a reasonable time for our own reporting regulatory requirements and to protect ourselves in the event of any legal claims and complaints.

Social plugins

The Website contains social plugins from social media platforms such as Facebook and Twitter. If you visit a website containing such a plugin, your browser can establish a direct connection with the servers of those social media platforms and transmit information about your surfing behaviour to their servers (e.g. even if you do not click the "Like" button). If you are logged into one of the social media sites, the social media platform can assign the visit to your social media account. Beas Cheerleading has no influence on the type and scope of the information collected and transmitted but may receive information through such channels and you may receive marketing from us via such social media platforms as a result of your browsing habits.

Cookies

We confirm the use of cookies and by using our site you accept the conditions of our Cookie Policy. If you prefer not to have cookies stored on your computer, you may change your

browser settings to either refuse all cookies, or to ask you if you wish to accept a cookie each time a website tries to store one. Please refer to our Cookie Policy for further information. If cookies are blocked, you may not be able to use all functions of our Website.

Children

If you are aged 13 or under, please obtain your parent or guardian's permission prior to providing any personal information to us. Children without this consent should not provide us with such information.

Dealing with other people

To comply with data protection legislation, to make the managing of your membership more convenient, it is our procedure to deal only with the parent/guardian of said athlete. If you would like someone else to be able to deal with your membership for you on a regular basis, please let us know.

In some exceptional circumstances, we may also deal with other people who call us on your behalf. If at any time you would prefer us to deal only with you, please email to let us know. In dealing with other people on your behalf we will need to process their personal information, please ensure you have the permission for us to process their information for such purposes to enable them to deal with your membership.

Security

Our internal procedures cover the storage, access and disclosure of information in accordance with data protection legislation. Please note that e-mails are not 100% secure. We advise that you take this into account before e-mailing personal and confidential information to us. If you send information by e-mail to us, you are doing so at your own risk. Your personal information may be held on computer or manual files.
